In The Matter Of: Systemic Crimes Against Humanity, Treason, Fraud, and Governmental Misconduct

To Be Enforced Upon: All individuals and entities implicated herein under the authority of lawful and constitutional principles, Common Law and International Law.

1. Crimes Against Humanity, Geo-engineering & Chemical Poisoning

1. Any Man or woman who knowingly takes part in or assists in the application of geo-engineering and substances commonly known as chemtrails shall be indicted and prosecuted under Crimes Against Humanity and Genocide for causing harm to The People and the environment of this great nation. Under The People's Court and International Law the offenders will be personally liable as there is no such thing as corporate immunity all are equal before the Law and following orders will not release you from what you criminally did.

Loyalty to the people is a fiduciary duty and upholding the Constitution is paramount.

Please recognise the serious threat posed by knowingly taking part or assisting in the deliberate chemtrailing and geo-engineering of this land.

1 A. Any man or woman who knowingly takes part in or assists in the application of harmful chemicals into the water such as fluoride, and other "forever" Chemicals and poisons shall be indicted and prosecuted under Crimes Against Humanity for causing harm to The People and the environment in this great nation" under international Law and rule of Law you will be personally liable as there is no such thing as corporate immunity all are equal before the Law and following orders will not release you from what you criminally did.

Thus people who deliberately partake in contamination of water supplies, whether through the addition of harmful chemicals such as fluoride or other pollutants into domestic and agricultural water systems, constitutes a direct attack on The People's health and causes harm to the entire eco system.

The water management Cheif Executiver Officer, man or woman who knowingly facilitate or approve these actions shall be indicted and prosecuted for Crimes Against Humanity."

2. Secret Societies & Harmful Oaths

Anyone who knowingly takes part in or helps enforce false oaths, secret society oaths, or any fraudulent oaths that go against the Commonwealth of Australia Constitution Act 1901 and put private interests above The People is acting unlawfully.

Groups like Freemasonry, the Corporate Australian Government, and other oath-bound organizations that demand secrecy and require members to act against the public's best interests, constitutional law, and natural justice are engaging in a conspiracy to pervertbthe course of justice.

Any individual found to be engaging in harmful, subversive, or conspiratorial activities through such societies may face indictment and prosecution for Crimes against humanity and in certain sectors breaching Fiduciary Duties .

3. Health Sector & Big Pharmaceutical Corporations, Bio-weapon Engineering

Any man or woman who knowingly taking part in or assisting with the development, authorisation, and distribution of mRNA-based bioweapons or experimental medical procedures that have resulted in harm, death, or long-term adverse effects, will be indicted and may be prosecuted under Crimes Against Humanity for items such as democide, mass harm, and medical negligence. 4. Environmental Crimes – Nuclear Waste Disposal

Any man or woman who knowingly takes part in or assists in the disposal of nuclear waste (excluding medical nuclear waste) onto our lands, waters, and communities causing a catastrophic risk to the environment and human health, and those who engage in such irresponsible practices shall be indicted and maybe prosecuted for environmental crimes and Crimes Against Humanity.

The people have the right to clean air, clean water, and an environment free from deliberate contamination and destruction. No private interest or government entity has the authority to compromise our natural resources for profit or control.

5. Media Manipulation & Suppression of Truth

Any man or woman who knowingly takes part in or assists in the mainstream media engaging in deliberate suppression, manipulation, and distortion of truth and withholding and/or restricting critical information from The People are co-conspirators in crimes against humanity. Any Australian News organisations such as the Australian Broadcasting Corporation ABC and other media corporation, who knowingly censor vital information and propagate falsehoods to deceive The People, shall be held accountable for aiding and abetting systemic harm and Crimes Against Humanity.

The duty of the press is to inform, not to deceive, and as of today, those who fail in this duty will be subject to investigation, indictment, and possible prosecution.

6. Child Protection & Unlawful Removal of Children

Any man or woman who knowingly takes part in or assists in unlawful removal of children from families without a proper certifiable and verifiable cause of action and lawful cause or due process – all Child Protection Departments/Agencies have engaged in the these acts constitute kidnapping, hostage-taking, and violations of human rights = slavery.

Any man or woman or social worker, judge, or government official involved in the unjustified removal of children without lawful due process shall be indicted and prosecuted for Crimes Against Humanity, child trafficking, and unlawful imprisonment.

The most sacred duty of any society is to protect its children. Yet, currently, institutions under the guise of Child Protection Departments and its work place contractors and employees are knowingly taking part in Child Trafficking and Crimes Against Humanity this crime.

7. Surveillance, Data Harvesting & Espionage

Any man or woman who knowingly takes part in or assists in the mass surveillance, unauthorised data harvesting, and targeting and tracking of individuals without a certified and verifiable cause of action are taking part in espionage and privacy violations.

Within the Commonwealth of Australia, any warrant granted for unlawful surveillance shall be considered an act of espionage, and those responsible will be indicted and may be prosecuted accordingly.

The right to privacy is non-negotiable.

8. Malfeasance of Office & Financial Crimes

Any man or woman who knowingly takes part in or assists in the malfeasance, abuse of power, financial fraud, or obtaining financial gain through deception will be indicted and prosecuted under international Law, Common Law and under Rule of Law for fraud and causing harm.

The misuse of public funds, bribery, and intentional misrepresentation in office are offences that must be met with the full force of lawful justice.

These Community Orders are to be of immediate effect, and all corporate persons, and men and woman, violating these principles shall be held accountable before The People’s Court, International Criminal Court in Gods sight.
